A RESOLUTION APPROVING THE DISBURSEMENT OF TWENTY-FIVE THOUSAND PESOS (PHP 25,000.00) AS BUDGET FOR THE CAMELLA LIPA HOMEOWNERS' ASSOCIATION, INC. MAYOR'S PERMIT FOR 2026
