BOARD RESOLUTION NO. 2026-33

A RESOLUTION AUTHORIZING THE DISBURSEMENT OF THREE THOUSAND ONE HUNDRED TWENTY PESOS (₱ 3,120.00) FOR THE PURCHASE OF MAINTENANCE UNIFORM


WHEREAS, the maintenance uniform is considered an essential operational requirement and forms part of the association's administrative and maintenance expenses;


