WHEREAS, during the said meeting, meals were provided to the Board members and participants to ensure the continuity, efficiency, and productivity of the proceedings;

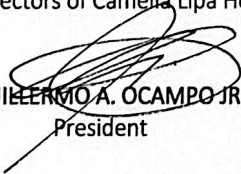
WHEREAS, the total meals expenses incurred in connection with the said meeting amount to two thousand eight hundred pesos (P2,800.00);

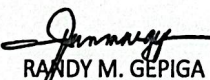
WHEREAS, such expense is considered necessary, reasonable, and properly chargeable to the association's funds in accordance with existing policies, rules, and regulations;

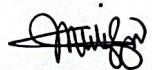

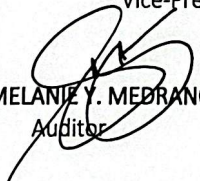
