BOARD RESOLUTION NO. 2025 – 58

A RESOLUTION APPROVING THE DISBURSEMENT OF ONE HUNDRED THOUSAND PESOS (PHP 100,000.00) AS BUDGET FOR THE SPECIAL GENERAL ASSEMBLY, CHRISTMAS LIGHTING, AND RELATED ACTIVITIES

WHEREAS, the Camella Lipa Homeowners Association, Inc. (the "Association") is a duly organized homeowners' association governed by its By-Laws, Rules and Regulations, and other governing documents adopted by the Board of Directors;

WHEREAS, the Board of Directors of Camella Lipa Homeowners' Association, Inc. convened in a face-to-face meeting on November 15, 2025, with a quorum present and acting throughout, and duly considered the following matters, among others, the disbursement of one hundred thousand pesos (PHP 100,000.00) as budget for the Special General Assembly, Christmas Lighting, and related activities;

WHEREAS, the Board of Directors finds it proper and necessary to allocate funds to cover all expenses related to the conduct of the Special General Assembly, Christmas lighting, decorations, food, and all other activities associated with the said day;

WHEREAS, the specified amount will be payable to RIZELL JOY U. FORTUS, Finance Officer, and will be subject for liquidation;

NOW, THEREFORE, BE IT RESOLVED, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors hereby approves the disbursement of one hundred thousand pesos (PHP 100,000.00) as budget for the Special General Assembly, Christmas Lighting, and related activities.
