BOARD RESOLUTION NO. 2022-010

RESOLUTION TO REQUEST TO ATTY. JANN ROBY R. OTERO, REGIONAL DIRECTOR, DHSUD REGION IV FOR THE IMMEDIATE IMPOSITION OF PENALTY IN VIOLATION OF PD 957, PD1216 AND ITS IRR OF COMMUNITIES BATANGAS INC. (CBI) DEVELOPER FOR NON DEVELOPMENT AND MAINTENACE OF CAMELLA LIPA SUBDIVISION

- WHEREAS, complaint was submitted to Department of Human Settlements and Urban Development last May 5, 2021 against Communities Batangas, Inc. regarding the alleged non-maintenance of Camella Lipa subdivision.
- WHEREAS, joint investigation and ocular inspection was held last June 2, 2021 to verify the allegation, check the status of development and verify CBI compliance with the implementing rules and regulations of PD 957 design standard and the condition of CBI License to Sell.
- **WHEREAS,** summary of ocular inspection report was submitted to Department of Human Settlements and Urban Development last June 17, 2021.
- WHEREAS, conference was held last June 29, 2021 at DHSUD Region 4A, Dencris Business Center, Brgy Halang, Calamba City Laguna concerning the filed complaint. Whereas, Communities Batangas Inc. was ordered to comply latest by July 13, 2021.
- WHEREAS, Communities Batangas Inc. failed to comply and Department of Human Settlements and Urban Development issued Notice to Violation last July 14, 2021.
- WHEREAS, the association submitted a Board Resolution NO. 2021 -033 to Department of Human Settlements and Urban Development last August 31, 2021 requesting to expedite their action for the said complaint.
- WHEREAS, Department of Human Settlements and Urban Development raised an Order of Imposition of Administrative Sanction (OIAS) last September 22, 2021 address to Communities Batangas Inc.
- WHEREAS, Communities Batangas, Inc. pay an Administrative Fine to Department of Human Settlements and Urban Development last October 20, 2021.
- WHEREAS, Department of Human Settlements and Urban Development issued Final Notice to Comply to Communities Batangas, Inc. due to except for the payment of the administrative fine they have not yet complied the other directives despite lapse of reasonable period. As such, Department of Human Settlements and Urban Development order is considered final and executory. Furthermore, the Cease- and Desist Order from further advertising, selling of units, and collecting amortization from buyers shall remain full force and effort unless permitted by this office. In view thereof, Communities Batangas, Inc. was given to ten (10) days non-extendable days from the date of receipt to comply with the cited order and other stipulated therein.
- WHEREAS, joint investigation and ocular inspection was held last March 2, 2022 to check the status of development and verify CBI compliance with the implementing rules and regulations of PD 957 design standard and the condition of CBI License to Sell.
- **WHERAS,** Communities Batangas, Inc. failed to attend the scheduled coordination meeting last March 5, 2022.
- WHEREAS, Communities Batangas, Inc. failed to action the said complaint and just accomplish minimal maintenance of drainage canal.
