BOARD RESOLUTION NO. 2022-048

RESOLUTION TO APPROVE THE DISBURSEMENT OF TWENTY THOUSAND PESOS AS A BUDGET FOR IN-COURT PROCEEDINGS VERSUS AKH SECURITY AGENCY, INC. ON AUGUST 25, 2022 AT METROPOLITAN TRIAL COURT NATIONAL CAPITAL JUDICIAL REGIOIN BRANCH LVIII(58) SAN JUAN CITY

WHEREAS, in the meeting of the Board of Directors last July 02, 2022 the Board of Directors of Camella Lipa Homeowners Association Inc., where a quorum was present and acted upon all throughout, the following proposals were made:

WHEREAS, the Board of Directors of Camella Lipa Homeowners' Association, Inc. received "SUMMONS" notice of in-court proceedings on August 25, 2022 at 9.00 in the morning from Metropolitan Trial Court National Capital Judicial Region Branch LVIII(58) San Juan City;

WHEREAS, AKH Security Agency, Inc claimed sum of money for the payment of security services rendered amounting to one hundred fifty six thousand two hundred forty pesos (Php 156,240.00) plus 2% interest per month starting from December 1, 2017 until fully paid, the cost of lawsuit, plus actual damages of P50,000, temperate damages of P50,000 and exemplary damages of P50,000 against Camella Lipa Homeowner Association, Inc. with its President Guillermo Ocampo and other officer namely Edison Hernandez, Rhea Mulingbayan, Kristine Alday, and Julian Fernando Runio;

WHEREAS, upon verification and validation, the Board of Directors of Camella Lipa Homeowners' Association agreed to settle the claim of AKH Security Agency, Inc. for the stale check covering the period November 1-15, 2017 amounting to seventy four thousand two hundred fifty pesos (Php 74,250.00) and lost check covering the period of May 16-31, 2017 amounting to seventy nine thousand two hundred pesos (Php 79,200.00);

WHEREAS, the Board of Directors of Camella Lipa Homeowners' Association, Inc. will attend the incourt proceedings on August 25, 2022 at 9.00 in the morning at Metropolitan Trial Court National Capital Judicial Region Branch LVIII(58) San Juan City;

WHEREAS, the said amount will be payable to Jingo Alvar, Finance Officer of Camella Lipa and subject for liquidation.

WHEREAS, AS IT HEREBY RESOLVED, that the Board of Directors unanimously approved the disbursement of twenty thousand pesos as a budget for the in-court proceedings versus AKH Security Agency, Inc. on August 25,2022 at Metropolitan Trial Court National Capital Judicial Region Branch LVIII(58) San Juan City.
