RESOLUTION TO APPOINT THE FINANCE OFFICER MR JINGO ALVAR TO PROCESS THE MANDATORY CONTRIBUTION OF HOA STAFF TO SOCIAL SECURITY SYSTEM, PHILIPPINE HEALTH INSURANCE CORPORATION AND PAG-IBIG FUND



WHEREAS, all government and private sector employers are required to register with Philippine Health Insurance Corporation to enable them to provide social health insurance coverage to their employees;


WHEREAS, under RA 7835, the government requires employers to register and contribute to the Pag-IBIG Fund;


