BOARD RESOLUTION NO. 2022-062

RESOLUTION TO APPROVE THE DISBURSEMENT OF SEVENTY-SIX THOUSAND THREE HUNDRED NAMED TO ASPAYMENT HUNDRED NINETY-NINE PESOS AND EIGHTY SIX CENTS (P 76,399.86) AS PAYMENT FOR THE UNPAID CONTRIBUTIONS OF HOA STAFF AND PENALTY TO SOCIAL SECURITY SYSTEM FTM MAY 2021 - OCTOBER 2022

- WHEREAS, in the meeting of the Board of Directors last November 5, 2022 of Camella Lipa Homeowners Association Inc., where a quorum was present and acted upon all throughout, the following proposals were made;
- WHEREAS, in 1997 Republic Act No. 8282 Section 9: Coverage, SSS shall be compulsory upon all employees not over sixty (60) years of age 1997;
- WHEREAS, in 1997 Republic Act No. 8282 Section 10: Effective Date of Coverage, compulsory coverage of the employer shall take effect on the first day of his operation and that of the employee on the day of his employment;
- WHEREAS, in 1997 Republic Act No. 8282 Section 22: Remittance of Contributions, every employer required to deduct and to remit such contributions shall be liable for their payment and if any contribution is not paid to the SSS as herein prescribed, he shall pay besides the contribution a penalty thereon of three percent (3%) per month from the date the contribution falls due until paid;
- WHEREAS, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors unanimously approved the disbursement of seventy-six thousand three hundred ninety-nine pesos and eighty six cents (P 76,399.86) as a payment for the unpaid contributions of HOA staff and penalty to Social Security System ftm May 2021 to October 2022;
- WHEREAS, the said amount will be payable to Jingo Alvar, Finance Officer of Camella Lipa and will be subject for liquidation;
- WHEREAS, AS IT HEREBY RESOLVED, that the Camella Lipa Homeowners' Association, Inc. through its Board of unanimously approved the disbursement of seventy-six thousand three hundred ninety-nine pesos and eighty six cents (P 76,399.86) as a payment for the unpaid contributions of HOA staff and penalty to Social Security System ftm May 2021 to October 2022.
