Failure to timely remit the appropriate premium contribution shall be subject to interest and penalties as prescribed by the Corporation without prejudice to other applicable penalties;




WHEREAS, the said amount will be payable to Jingo Alvar, Finance Officer of Camella Lipa and will be subject for liquidation;


