



**BOARD RESOLUTION NO. 2022-076**

**RESOLUTION TO APPROVE THE DISBURSEMENT OF ELEVEN THOUSAND THREE HUNDRED NINETY-SEVEN PESOS AND SEVEN CENTS (P 11,397.07) AS PAYMENT FOR THE UNPAID CONTRIBUTIONS OF HOA STAFF TO Pag-IBIG FUND (PAGTUTULUNGAN SA KINABUKASAN: IKAW, BANGKO, INDUSTRIYA AT GOBYERNO) FTM MAY 2021 - NOVEMBER 2022**

**WHEREAS**, in the meeting of the Board of Directors last December 3, 2022 of Camella Lipa Homeowners Association Inc., where a quorum was present and acted upon all throughout, the following proposals were made;

**WHEREAS**, in IRR Republic Act No. 9679 otherwise known as Home Development Mutual Fund Law of 2009, otherwise known as Pag-IBIG Fund (Pagtutulungan sa kinabukasan: Ikaw, Bangko, Industriya at Gobyerno) Rule V Fund coverage and Membership Section 1. Mandatory Coverage and Membership for Employees, coverage under and membership in the fund shall be mandatory for (a.) all employees who are compulsorily covered by SSS; provided, that for purposes of mandatory coverage in the fund of persons who are compulsorily covered by SSS, the term employee shall be understood the manner by which the SSS defines, it, and shall include, but not limited to: (1) a private employee, whether permanent, temporary or provisional, who is not over 60 years old;

**WHEREAS**, in IRR Republic Act 9679 otherwise known as Home Development Mutual Fund Law of 2009, otherwise known as Pag-IBIG Fund (Pagtutulungan sa kinabukasan: Ikaw, Bangko, Industriya at Gobyerno) ) Rule V Fund coverage and Membership Section 2. Mandatory Coverage of Employers, coverage under the Fund shall be mandatory for the employers of employees compulsorily covered by SSS. These shall include private employers previously granted waiver or suspension of coverage for whatever reason under Presidential Decree 1752 as amended;

**WHEREAS**, in IRR Republic Act No. 9679 otherwise known as Home Development Mutual Fund Law of 2009, otherwise known as Pag-IBIG Fund (Pagtutulungan sa kinabukasan: Ikaw, Bangko, Industriya at Gobyerno) Rule VI Contributions Section 1 : Rate of Contributions, all employers -two (2%) percent of the monthly compensation of all covered employees;

**WHEREAS**, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors unanimously approved the disbursement of eleven thousand three hundred ninety seven pesos and seven cents (P 11,397.07) as a payment for the unpaid contributions of HOA staff to Pag-IBIG Fund (Pagtutulungan sa kinabukasan: Ikaw, Bangko, Industriya at Gobyerno ftm May 2021 to November 2022;

**WHEREAS**, the said amount will be payable to Jingo Alvar, Finance Officer of Camella Lipa and will be subject for liquidation;

**WHEREAS, AS IT HEREBY RESOLVED**, that the Camella Lipa Homeowners' Association, Inc. through its Board of unanimously approved the disbursement of eleven thousand three hundred ninety seven pesos and seven cents (P 11,397.07) as a payment for the unpaid contributions of HOA staff to Pag-IBIG Fund (Pagtutulungan sa kinabukasan: Ikaw, Bangko, Industriya at Gobyerno ftm May 2021 to November 2022.
