WHEREAS, the association authorize R/1 Enterprises to deliver LPG supply inside the subdivision exclusively;


WHEREAS, the association will prohibit other LPG suppliers and deliveries inside the subdivision exempt when homeowners personally bought the LPG;

WHEREAS, the association main priority is to provide safe and reliable LPG supplier inside the subdivision;


