 - To recognize and respect the position and authority of all the elected and 4.5. appointed officers of the association, as well as respect the rights of other members.
- WHEREAS, in the IRR No. 9904 Magna Carta for Homeowners and Homeowners Association Rule III Membership in the Association Section 13. Rights of a Member. A member shall have the following rights:
 - a. Participate, vote and be eligible for any elective or appointive office of the association subject to the qualifications as provided for in the bylaws, and in this Rules;
 - b. Participate in association meetings, elections and referenda, Provided, the member is in good standing, unless otherwise provided in the bylaws, and existing rules and regulations of DHSUD, or ordered in final decisions of the HLURB/HSAC or ordered by DHSUD when acting as a special Election Committee under special circumstances;
