RESOLUTION TO PERMIT OTHER LPG SUPPLIERS TO DELIVER INSIDE CAMELLA LIPA PHASE 1-6

WHEREAS, in the meeting of the Board of Directors last April 26, 2024 of Camella Lipa Homeowners Association Inc., where a quorum was present and acted upon all throughout, the following proposals were made;
