- WHEREAS, the Gate 1 near HOA Office at Phase 1 will be closed but the pedestrian gate will still be open 24/7;
- WHEREAS, the Gate 2 entrance and exit open 24/7 (at the middle road intersecting CONDO and main road) for:
 - Residents with sticker ONLY;
 - b. Visitors / Tricycle commuters / Ride hailing app riders;

WHEREAS, the Gate 3 at Phase 4 entrance and exit will be open from 5AM to 10PM only for;

- a. Residents with or no sticker;
- b. Visitors;
- c. Contractor;
- d. Delivery;

WHEREAS, all Contractor and Delivery vehicles must exit Gate 3 on or before 10 PM;

WHEREAS, the changes on the traffic flow will be implemented on June 26,2024 7.00 am:

WHEREAS, the main objective of the new traffic flow scheme is to intensify the safety and security of the residents within our community and to have more effective control / logging on the entry and exit of all the vehicles;
