RESOLUTION TO APPROVE THE DISBURSEMENT OF SIX THOUSAND FOUR HUNDRED THIRTY-EIGHT PESOS AND 50/100 (P 6,438.50) AS BUDGET FOR THE PROCUREMENT OF A CUSTOMIZED TARPULIN FOR THE CAMELLA LIPA CLUBHOUSE

WHEREAS, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors unanimously approve the disbursement of six thousand four hundred thirty-eight pesos and 50/100 (P 6,438.50) as a budget for the procurement of a customized tarpaulin for the Camella Lipa Clubhouse;
