BOARD RESOLUTION NO. 2026-32

A RESOLUTION AUTHORIZING THE DISBURSEMENT OF EIGHT THOUSAND FIVE HUNDRED PESOS (₱ 8,500.00) FOR THE PURCHASE OF FIVE (5) UNITS OF 400W SOLAR STREETLIGHTS

WHEREAS, the Camella Lipa Homeowners Association, Inc. (the "Association") is a duly organized homeowners' association governed by its By-Laws, Rules and Regulations, and other governing documents adopted by the Board of Directors;

WHEREAS, the Board of Directors of Camella Lipa Homeowners' Association, Inc. convened in a face-to-face meeting on March 28, 2026, with a quorum present and acting throughout, and duly considered the following matters, among others, authorizing the disbursement of eight thousand five hundred pesos (₱ 8,500.00) for the purchase of five (5) units of 400w solar streetlights;

WHEREAS, the Board of Directors recognizes the importance of adequate street lighting in promoting security, visibility, and safety within residential areas, particularly during nighttime hours;

WHEREAS, several portions of the subdivision have been identified as inadequately illuminated, thereby posing potential risks to safety, security, and peace and order within the community;

WHEREAS, the installation of solar-powered streetlights is a practical, energy-efficient, and cost-effective solution that reduces operational expenses while improving night visibility;


WHEREAS, after due evaluation and assessment, the Board has determined the necessity of procuring five (5) units of 400W solar streetlights to immediately address lighting deficiencies in critical areas;


WHEREAS, the total cost amounting to eight thousand five hundred pesos (₱ 8,500.00) has been reviewed and found to be reasonable which shall be chargeable against the Association's Other Income – Bank Account;

WHEREAS, the said amount shall be payable to RIZELL JOY U. FORTUS, Finance Officer, and shall be subject to liquidation in accordance with the association's accounting and auditing policies;

NOW, THEREFORE, BE IT RESOLVED, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors hereby approves the disbursement of eight thousand five hundred pesos (₱ 8,500.00) for the purchase of five (5) units of 400w solar streetlights.
