
WHEREAS, the volume of waste generated by Camella Lipa Phases 1-6 increased in comparison to prior months.;


WHEREAS, the rubbish was piled up in the MRF, resulting in a bad odor and the presence of insects and bacteria;


WHEREAS, the said amount is payable to GOMI PHILS. INC.;






