We wish to inform you that the new vehicle sticker is now available at the HOA office and will be diligently enforced starting **February 9, 2026**. The association encourages all homeowners, tenants, and service providers to register and renew their vehicle stickers for the year 2026.

We kindly request that you adhere to the guidelines and information provided below.

New application:

- Application form (available at HOA Office)
- Photocopy of driver's license
- Photocopy of O.R and C.R. or sales invoice if not available

Renewal:

- Renewal form (available at HOA Office)
- Photocopy of driver's license (not required if the submitted ID is still valid)
- Photocopy of O.R or sales invoice if not available (not required if the submitted OR is still valid)

Note:


- ❖ Only registered tenants who fulfill all requisite conditions are eligible to apply for a vehicle sticker.
- ❖ An authorized representative must submit a copy of the authorization letter or Special Power of Attorney (SPA), along with their identification and that of the homeowner.
- ❖ Deed of Sale (if a second owner)
- ❖ Service providers are advised to coordinate with the Homeowners Association (HOA) office for verification purposes. It is imperative to present all necessary documentation (e.g., operating license, permits, homeowner authorization).
- ❖ Vehicle sticker is required to be affixed to the upper or lower left side of the windshield
