BOARD RESOLUTION NO. 2026-37

A RESOLUTION AUTHORIZING THE DISBURSEMENT OF TEN THOUSAND PESOS (₱10,000.00) FOR THE FABRICATION OF THREE RECYCLING WASTE BINS

WHEREAS, the Camella Lipa Homeowners Association, Inc. (the "Association") is a duly organized homeowners' association governed by its By-Laws, Rules and Regulations, and other governing documents adopted by the Board of Directors;

WHEREAS, the Board of Directors of Camella Lipa Homeowners' Association, Inc. convened in a face-to-face meeting on March 28, 2026, with a quorum present and acting throughout, and duly considered the following matters, among others, authorizing the disbursement of ten thousand pesos (₱10,000.00) for the fabrication of three recycling waste bins;

WHEREAS, the association recognizes the importance of maintaining cleanliness, proper waste segregation, and environmental responsibility within the subdivision;

WHEREAS, the Board of Directors finds it necessary to fabricate three (3) recycling waste bins to be placed at the Butterfly Garden, Swimming Pool Area, and Basketball Court for the convenience of residents and visitors;

WHEREAS, the association shall undertake the fabrication of the said recycling waste bins and shall engage the services of a welder for the necessary labor and assembly works;


WHEREAS the total amount required for the purchase of materials, welding services, labor, and incidental expenses is ten thousand pesos (₱10,000.00) which shall be chargeable against the Association's Other Income – Bank Account;

WHEREAS, the said amount shall be payable to RIZELLJOY U. FORTUS, Finance Officer, and shall be subject to liquidation in accordance with the association's accounting and auditing policies;

NOW, THEREFORE, BE IT RESOLVED, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors hereby approves the disbursement of ten thousand pesos (₱10,000.00) for the fabrication of three (3) recycling waste bins, inclusive of materials, welding services, labor, and related expenses.
