## RESOLUTION TO APPROVE THE DISBURSEMENT OF EIGHT THOUSAND FIVE HUNDRED EIGHTY-TWO PESOS AND NINETY-FIVE CENTS (P 8,582.95) AS A BUDGET FOR RUBBER SPEED HUMPS FOR COMMUNITY ROADS

- WHEREAS, in the board meeting of the Board of Directors last May 10, 2025 of Camella Lipa Homeowners Association Inc., where a quorum was present and acted upon all throughout, the following proposals were made;
- WHEREAS, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors unanimously approve the disbursement of eight thousand five hundred eighty-two pesos and ninety-five cents (P 8,582.95) as a budget for rubber speed humps for community roads;
