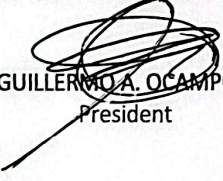
WHEREAS, pursuant thereto, Ms. Gloria G. Ilagan was designated and appointed as Secretary of the association;

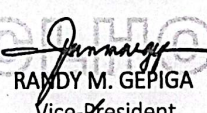
WHEREAS, the updated General Information Sheet likewise includes the duly recognized committee members of the association;

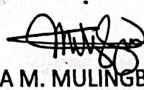

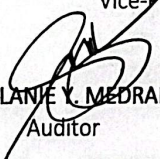
