BOARD RESOLUTION NO. 2026-80

A RESOLUTION AUTHORIZING THE DISBURSEMENT OF TWO THOUSAND FIVE HUNDRED PESOS (P2,500.00) FOR THE PROCUREMENT OF ONE (1) SOLAR STREETLIGHT FOR AN UNCONNECTED ELECTRICITY LINE IN PHASE 5

WHEREAS, the Camella Lipa Homeowners Association, Inc. (the "Association") is a duly organized homeowners' association governed by its By-Laws, Rules and Regulations, and other governing documents adopted by the Board of Directors;

WHEREAS, the Board of Directors of Camella Lipa Homeowners' Association, Inc. convened in a face-to-face meeting on August 1, 2026, with a quorum present and acting throughout, and duly considered the following matters, among others, procurement of one (1) solar streetlight for an unconnected electricity line in phase 5;

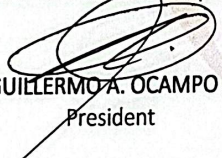
WHEREAS, the Board of Directors recognizes the need to provide adequate lighting in an area of Phase 5 where the existing streetlight is not connected to an electrical line, in order to enhance the safety and security of residents;

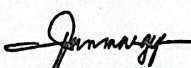
WHEREAS, the procurement and installation of one (1) solar streetlight is deemed to be a practical and cost-effective solution to illuminate the affected area;

WHEREAS, under Board Resolution No. 2026-11, all disbursements and expenses exceeding two thousand five hundred pesos (P2,500.00) require prior approval by the Board of Directors through a Board Resolution, and such approved disbursements may be paid through Petty Cash without the issuance of a check;

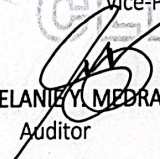

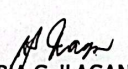
