- Ultimate Domain Protection and Security Renewal – P1,678.88




WHEREAS, the specified amount will be payable to RIZELL JOY U. FORTUS, Finance Officer, and will be subject for liquidation;





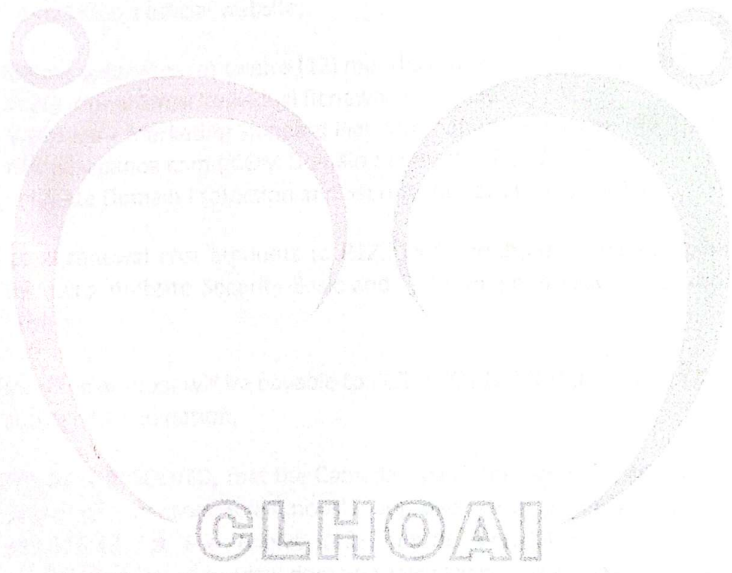
