BOARD RESOLUTION NO. 2026-65

A RESOLUTION AUTHORIZING THE DISBURSEMENT OF FOUR THOUSAND NINE HUNDRED PESOS (P4,900.00) FOR THE PROCUREMENT OF SAFETY BOOTS AND RAINCOATS FOR THE MAINTENANCE PERSONNEL

NOW, THEREFORE, BE IT RESOLVED, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors hereby approve the disbursement of four thousand nine hundred pesos (P4,900.00) for the procurement of safety boots and raincoats for the association's maintenance personnel.
