## COMMUNICATION GUIDELINES FOR OUR CLIENTS

### PHONE CALL POLICY

**Appointments Required:** To accommodate my current workload and ensure productive conversations, all phone calls requiring more than five minutes must be scheduled in advance. Unscheduled calls may not receive immediate attention as I could be in court, in meetings, or focused on other cases.

**Scheduling Calls:** Appointments can be set via email or Practice Panther. Conversations requiring more than five minutes will be scheduled to allow for preparation and attention to your concerns.

**Unscheduled Office Visits:** Please refrain from dropping by the office without an appointment. This policy ensures all clients receive dedicated and uninterrupted time.

### EMAIL POLICY

**Response Time:** Emails will be addressed in the order received. Please allow at least 72 hours for a response, excluding weekends.

**Urgent Matters:** Include "URGENT" in the subject line for pressing issues.

**Ease of Reference:** Add your case caption (e.g., Jane Doe vs. John Doe) in the subject line or body of the email.

**Copying the Team:** To ensure a prompt response, copy the appropriate paralegal, legal assistant, or secretary assigned to your case on all email communications.

### TEXT MESSAGE POLICY

**Business Use Only:** Text messages may be sent occasionally for straightforward matters, but only from the firm's business cell phone.

**Restricted Use:** Staff personal cell phone numbers will not be provided to clients except in rare, necessary circumstances.
