

It is with great joy and excitement that we the GJ-BGRC proclaim that this years Green Jacket tournament will be held the first week of September 2019.

New to 2019 we are implementing rule # 121-24423 which states:

"As it is obvious that the right honorable Green Jacket participants are getting along in age and with that their level of play is most certainly tarnishing the credibility of this most prestigious event we know and love called "The Green Jacket Tournament", it is this rules and ethics committee's decision that a qualifying round must be challenged no more than one day prior to the official start of that years Green Jacket tournament. This qualifying round will be for all Green Jacket participants with exceptions to those who have achieved a Green Jacket "exceptional status" level. The 18 hole round must be scored lower that 100 to be eligible to play in that years Green Jacket tournament.

To inform those who are challenging for this years coveted Green Jacket - qualifying rounds will need to be played by credited Green Jacket participant # 1 (Dale Clarke of Grande Prairie Alberta) \*\*somewhat credited Green Jacket participant # 2 (Terence Allan Clarke of no fixed address) credited Green Jacket participant # 3 (Darcy Paul Clarke of County of Grande Prairie) and credited Green Jacket participant #5 (Colleen Adele Clarke of Edmonton Alberta)

Both credited Green Jacket participants # 4 and # 6 have achieved "exception status" by meeting the requirements stated in the manual and online under - rule/exceptional/status:

# 2993-44847c exceptional status will be granted to Green Jacket participants who have won a major tournament in the past

# 2994-32436f exceptional status will be granted to Green Jacket participants whom have won Green Jacket titles back to back

Dearest credited Green Jacket participant GT P #02 <u>Terence Allan Clarke</u> of no fixed address.

It has come to our attention that you <u>Terence Allan Clarke</u> of no fixed address are in violation of Green Jacket rule # 198-33212b which states:

"If the previous winner of the Green Jacket does not repeat as Green Jacket champion in the following year, the previous winner must in all ways at least that in which is acceptable and pleasing to the new Green Jacket champion relinquish the Green Jacket in an expedited fashion or be penalized 1 stroke for every week the previous champion is late".

This matter has come to our attention by an anonymous credited Green Jacket participant whom shall remain nameless as is his right under rule # 455-32213a sub-sections 2a which states:

"If a credited Green Jacket participant has a grievance with another credited Green Jacket participant, then it is the decision of this rulings and ethics committee to allow that credited Green Jacket participant the right to remain anonymous and receive rulings and ethics committee support in representing his claims of grievance to the grieved upon Green Jacket participant"

Since you or legal counsel representing you were not present at the Board of Governors and Ruling Committee's grievance court date June 3<sup>rd</sup> 2013 in Edmonton, Alberta to argue against claims brought upon you which were and are validated by article #'s 1a and 1b, it is the Boards decision that you are indeed in violation of this Green Jacket rule # 198-33212b and hence fourth have been penalized such as to be accurate with this penalties ruling.

Please understand that if the Green Jacket has not been received by the rightful recipient within 5 business days of receiving this letter then further civil action may be taken by the rightful Champion of the Green Jacket as is his right under Green Jacket rule # 244-54651d which states:

"If Board of Directors and Rulings committee find in favour of a grieved upon decision the rightful Green Jacket participant has the right to further claim in a Civil fashion that which he desires and will have the full support of this Committee"
