### Meeting was called to order 7:10pm

- > Owner's Forum & Committee Reports
- ➤ **Approval of Minutes:** December 7, 2022, Bill Riban made the motion to approve minutes, Marc Heisler seconded the motion.

### President's Report:

- Email waivers have been signed for 39/40 townhomes
- API update: increase in monthly contribution to Reserve Account at Ed Jones to \$4,395. This is an increase of \$610 from last year's monthly contribution of \$3,785.
- Approved on December 22, 2022: purchase of \$35,000 for CDs, rate 4.65%.
  (Total available in Ed Jones Reserve Operating account is \$47,000.)
- Completed Contracts December 2022 and January 2023
  - 1. OD Construction Gutter diverters on 7 units, \$600, completed in December, 2022
  - 2. Chicago Hardscape Rainwater swale behind building # 4, \$950, completed in December, 2022
  - 3. Elevations Dormant Burning Bush trim #7266 for \$2,080.00, January 4, 2022
- Reviewed recommendations and concerns made by residents at the November Neighborhood meeting and December Annual CPTOA Meeting.

#### > Treasurer's Report

- Approved December 2022 Financial Report
- Reviewed Budget for 2023, began to develop a working plan for 2023

## Unfinished-Ongoing Business

- Snow Service used once in December, 2022
- Discussed request by owner of Unit 0N678 for partial driveway replacement

#### New Business

- Review/discuss contract with API.
  - 1. Review notification process by API to handle requested repairs by homeowner up to \$500 without the need for Board approval.
  - 2. Improve "check & balance" system of API's response to owner requests
- Consider creating a plan for Gutter Cleanout rather than by random owner request

- Approved to hold three General Meetings per year –Dates will be selected with the Social Committee and posted for 2023
  - April Neighborhood Meeting
  - October Neighborhood Meeting
  - December 6th Annual Board Meeting API hosts
- Recommend Social Committee to hold TGIF driveway gatherings as scheduled by the Social Committee for summer of 2023
- Discussed holding small meetings for input to create plans for 2023 and beyond.
  - <u>Financial review</u> meet with interested neighbors during <u>February</u>
    March to:
    - Create a financial plan for the next 5 or 10 years
    - Review CPTOA insurance plan
  - 2. <u>Landscape review</u> meet with interested neighbors during <u>March April</u> to review landscaping needs
    - Replanting of trees/bushes in bare/woodchip areas
    - Ground cover
    - Consider sealing our wood fence along County Farm Rd
  - 3. <u>Maintenance review</u> meet with interested neighbors during <u>March April</u> to:
    - Painting and gutter replacement
    - Concrete work
    - Gutter cleaning plan
    - Review Maintenance Matrix and Responsibility update in the near future
