

**COMPLAINT TO (I) TERMINATE TIMESHARE PLANS, AND (II) SELL ESTATE'S  
INTEREST AND CO-OWNER'S INTEREST IN REAL PROPERTY PURSUANT TO  
11 U.S.C. § 363(h)**

HDLV Consolidation, LLC (the "Debtor"), the debtor and debtor-in-possession in the above-referenced chapter 11 case, files this Complaint to (I) Terminate Timeshare Plans, and (II) Sell Estate's Interest and Co-Owner's Interest in Real Property Pursuant to 11 U.S.C. § 363(h).

**Parties**

1. The Debtor, a Texas limited liability company, may be served with pleadings and process in this adversary proceeding through its undersigned counsel.
2. The Defendants are owners of timeshare interests in the Property (defined below). There is a total of 1367 Defendants. A full list of the Defendants and their service address is attached hereto as **Exhibit A**.

### **Jurisdiction**

3. The Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2)(A), (N), and (O). Venue is proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409.

4. The Debtor has complied with Rule 7001(3) of the Federal Rules of Bankruptcy Procedure which requires a debtor to file an adversary proceeding in order to sell a non-debtor, co-owner's interest in property pursuant to 11 U.S.C. § 363(h).

### **Brief Statement of the Case**

5. The Debtor files this complaint to obtain declaratory relief that (i) terminates the timeshare plans governing the Property (defined below), and (ii) permits it to sell the entire Property, including the non-debtor, co-owners' interests, pursuant to 11 U.S.C. § 363(h). Subject to obtaining the relief sought in this Complaint, the Debtor intends to file a motion in the main bankruptcy case seeking approval to (i) engage an auctioneer to market the Property, and (ii) sell the entire Property by public auction free and clear of all liens, claims, encumbrances, and interests pursuant to 11 U.S.C. § 363(f). The net sales proceeds will be distributed to the co-owners of the Property through a plan of liquidation in the main bankruptcy case. Any Defendant listed on Exhibit A who does not oppose a sale of the Property is not required to file an answer or other responsive pleading to this Complaint.

### **Statement of Facts**

6. The Debtor is a Texas limited liability corporation that owns timeshare interests in a property known as Hotel de L'Eau Vive located at 315 and 327 Tchoupitoulas, New Orleans, Louisiana 70130 (the “Property”).

7. The Property consists of three neighboring structures. The first section of the Property was originally developed as a timeshare project under the name Maison Orleans in 1989. A subsequent developer added two additional phases in the 1993 and 1998. Each phase of the Property was created with a separate owners' association (collectively, the "Associations").<sup>1</sup>

8. The Property is accordingly subject to three different timeshare declarations. The original owner and developer of the first phase of the Property executed and filed the Maison Orleans Timeshare Declaration, dated November 30, 1983, in the records of the Registrar of Conveyances of Orleans Parish (as amended, the "First Declaration"). The First Declaration was amended several times, most recently the Second Amendment to the First Amended and Restated Timeshare and Condominium Declaration Creating and Establishing Hotel De L'Eau Vive, A Condominium, was dated and recorded on October 9, 1992.

9. The developer of the second phase of the Property executed and filed the Timeshare and Condominium Declaration Creating and Establishing Hotel De L'Eau Vive, II, A Condominium, dated as of June 9, 1993 (as amended, the "Second Declaration"). The Second Declaration was amended by the First Amendment to Timeshare and Condominium Declaration Creating and Establishing Hotel De L'Eau Vive II, a Condominium, dated as of November 1, 1994.

10. The developer of the third phase of the Property executed and filed the Timeshare Declaration Creating and Establishing Hotel De L'Eau Vive III Timeshare Condominiums, dated as of July 21, 1998 (the "Third Declaration" and collectively with the First Declaration and the Second Declaration, the "Declarations").

<sup>1</sup> The Associations are Hotel De L'Eau Vive Owners' Association, Inc., Hotel De L'Eau Vive Owners' Association II, Inc., and Hotel De L'Eau Vive Owners' Association III, Inc. The day-to-day operations of all three Associations are managed by Hotel De L'Eau Vive Owners' Association, Inc.

11. Across the three phases, the Property consists of a total 34 units that are split into a total of 1768 timeshare interests held by hundreds of parties, including the Debtor. Each timeshare interest entitles the owner to a fixed week of occupancy. The Debtor owns a total of 591 timeshare interests in the Property, including at least one timeshare interest in each of the units.

12. The Property, like many other timeshare properties, has suffered greatly from attrition among its owners over the years. While this is an industry-wide trend, the Property's ability to collect maintenance fees has been impacted by Hurricane Katrina, the recession of 2008 and the COVID-19 pandemic. As owners cease paying their maintenance fees, the Associations have limited options for generating additional revenue and lack the necessary funds to perform regular maintenance and capital expenditures.

13. On April 26, 2024, the city of New Orleans forced the Property to close as a result of safety and permitting issues. The New Orleans Fire and Permitting Departments cited concerns with the fire suppression system, elevator, exit signage and lighting, and water intrusion.

14. As a result of this action by the city, the Property cannot be used for its intended purpose at this time—no Defendant can currently use their timeshare interest and the Defendant cannot generate revenue from short term leases through its interests in the Property.

15. The necessary repairs and improvements to the Property that would be required to reopen are anticipated to cost hundreds of thousands dollars or more and may take several months to complete. The Associations currently lack the liquidity or financing to fund these repairs.

16. In light of these circumstances, the Property is no longer viable as a timeshare resort, but continues to be bound by the covenants, conditions and restrictions of the recorded timeshare declarations through 2048. The only feasible solution is to terminate the timeshare plans and order a sale of the Property with the proceeds to be divided equitably among the co-owners.

17. Article XIV of each of the Declarations provides that the respective timeshare plan (each, a “Timeshare Plan”) may be terminated:

upon entry of a final judgment by a court of competent jurisdiction in an action brought by an owner of a Timeshare Unit or the Association declaring that the useful life of the Condominium Property or the portion thereof subject to timeshare use has ended that portion of the Condominium Property subject to timeshare use shall be withdrawn from the condominium regime and the Timeshare Plan terminated with respect thereto.

18. Following termination of the Timeshare Plan, Article XIV of the Declarations each provide that, pursuant to Section 9:1131.8 of the Louisiana Timesharing Act, the Association may sell, convey, or otherwise dispose of the former Timeshare Unit Owners’ interest with the proceeds to be distributed to each former Timeshare Unit Owner in accordance with such owner’s percentage ownership in the Property.

19. Section 9:1131.8 of the Louisiana Timesharing Act tracks the language set forth in Article XIV of the Declarations and similarly provides that the timeshare plan shall terminate “upon entry of a final judgment by a court of competent jurisdiction brought by an owner or the association declaring that the useful life of the timeshare property has ended.”

### **Requests For Declaratory Relief**

20. The Debtor requests the Court enter declaratory relief providing that (i) the timeshare plans are terminated, and (ii) the Debtor may sell the non-debtor, co-owners’ interest in the Property pursuant to 11 U.S.C. § 363(h).

### **Count I – Declaratory Relief Terminating the Timeshare Plans**

21. Article XIV of the Declarations and Section 9:1131.8 of the Louisiana Timesharing Act provide that the three Timeshare Plans creating the Associations and governing the Property may be terminated upon a judicial declaration that “the useful life of the timeshare property has ended.”

22. Years of declining ownership and the reduction of owners paying maintenance fees have left the Associations unable to adequately maintain the Property for its intended use as timeshares.

23. The city of New Orleans' recent action forcing the Property to close means that the Defendants cannot use the Property for its intended purpose. The Associations lack the resources to perform the necessary repairs to the Property.

24. Accordingly, the Debtor requests that this Court enter a declaratory judgment that the useful life of the Property as timeshares has ended and that the Timeshare Plans are thereby terminated in accordance with the terms of the Declarations and applicable law. This relief will permit the Property to be sold in its entirety with the proceeds to be distributed equitably to the Debtor and the Defendants.

**Count II – Declaratory Relief Pursuant to 11 U.S.C. § 363(h)**

25. Section 363(h) of the Bankruptcy Code allows the Debtor to sell a non-debtor, co-owner's interest in property if the following requirements are satisfied:

- a. Partition in kind of such property among the estate and such co-owners is impracticable;
- b. Sale of the estate's undivided interest in such property would realize significantly less for the estate than sale of such property free of the interests of such co-owners;
- c. The benefit to the estate of a sale of such property free of the interests of co-owners outweighs the detriment, if any, to such co-owners; and
- d. Such property is not used in the production, transmission, or distribution, for sale, of electric energy or of natural or synthetic gas for heat, light, or power.

26. The Defendants are the co-owners of the Property. Pursuant to the Declarations and applicable Louisiana law, upon termination of the Timeshare Plans (the relief sought in Count I), the Property is to be sold with the net sales proceeds to be distributed equitably to the owners.

27. The Debtor requests authority to conduct such a sale pursuant to 11 U.S.C. § 363(h).

28. Partition in kind of the Property is impracticable because each unit is owned in timeshare week increments and cannot be partitioned.

29. The proposed sale of the entire Property will realize significantly greater benefit to the estate than selling the estate's undivided timeshare interests in each unit. In fact, given the minimal cash flows at the Property and the existing debt, it likely would not be possible to locate any buyer who would be willing to acquire only the Debtor's timeshare interests.

30. The Defendants do not occupy the Property. The Defendants cannot use their timeshare interests due to the Property being shut down by the city of New Orleans. Many of the Defendants are timeshare relief companies that exist for the purpose of previous owners shielding themselves for liability from maintenance fees.

31. The Defendants' interest in the Property will attach to the sales proceeds, and the Debtor will file a plan of liquidation proposing to distribute the net sale proceeds equitably to the Defendants based on their proportional ownership interest in the Property.

32. Accordingly, no Defendants will be displaced from their home by the proposed sale, and the benefit to the estate outweighs any potential detriment to the Defendants.

33. The Property is not used in the production, transmission, or distribution, for sale, of electric energy or of natural or synthetic gas for heat, light, or power.

Accordingly, the Debtor requests that the Court enter a declaratory judgment finding that (i) the useful life of the Property as a timeshare has ended and the Timeshare Plans are terminated in accordance with the terms of the Declarations and applicable law, and (ii) the Debtor may sell the entire, undivided interest in the Property, including the interests held by the Defendants, pursuant to 11 U.S.C. § 363(h) and grant the Debtor other just relief.


