- I. **Agreement.** I agree to enter into a modeling agreement with Prismatic Productions ("the Company") and its agent, Brent Parris ("the Photographer"), in consideration for monetary remuneration. - II. **Capacity and Consent.** I declare that I am the individual depicted in the Images taken in association with this release and waiver of rights form; that I am over the age of 18 years; that I possess the full legal capacity to execute this modeling agreement; that I was not under the influence of any drugs, alcoholic beverages, or mind-altering substances at the time the Images were taken; and that I had the legal capacity to consent to the Images while they were being taken, shot, or captured.
- III. **Payment and Release.** In consideration of the payment of \$ \_\_\_\_\_, I hereby grant the Company and Photographer all rights in perpetuity of the Images to be produced. Without limiting the generality of the foregoing, and in addition thereto, I grant the Company and Photographer perpetual rights to any and all Images, whether by means of photographs, videotapes, computer media, and/or by any other means, now known or unknown, including perpetual and exclusive rights: (i) to copyright, copy, or reproduce, by any present or future means, all or any part of the Images; (ii) to exhibit, display, print, disseminate, set, assign, and/or transmit any or all of the Images, whether by means of still photographs, magazines, motion pictures, videodiscs, videotapes, computer discs. Internet web sites, streaming Internet feeds, and/or by any other means, now known or unknown; (iii) to use the Images in connection to advertising, including without limitation, in videos, magazines, newspapers, books, one-sheets, flyers, catalogs, and covers or wrappers of recordings, discs, and/or tapes; and in connection with the sale of any collateral products or merchandising; (iv) to use the Images, or any parts thereof, in a compilation of still photographs, magazines, motion pictures, videodiscs, videotapes, computer discs. Internet websites, streaming Internet feeds, and/or in connection with the sale of related products or merchandise relating thereto; and to reproduce and/or transmit the same by, and in, any and all, media; and (v) to edit, add, arrange, re-arrange, alter, or distort the Images in any manner Company, in its sole and complete discretion, may determine at any time.
