History



Rainbow House began in November, 1986 in an old farmhouse with room for up to twelve children. Kathy Hughes, founder, had been a foster parent for many years. She had the vision to provide a safe, home-like environment where sibling groups would be kept together and children would continue in their home school. Her compassion for children, sincere dedication and ability to mobilize the community resulted in the founding of the only children's emergency shelter in Mid-Missouri. The agency has historically provided placement for children age birth to eighteen years.

In 1992, services were expanded to include crisis care. This program provides for children whose parents are in crisis and need a safe place to house their children while they attempt to stabilize their own lives. Crisis Care is truly a prevention program in that it provides a respite placement that can be accessed by a parent without involvement of any other agencies. Parents may face a major crisis including homelessness, unemployment, temporary mental instability, or other issues that can cause major stress in one's life. Crisis Care can relieve the parent of the added stress of parenting at the same time they are trying to solve their crisis. It is our belief that children are protected from abuse because parents choose to utilize this Rainbow House service.

Many years later, ICAN (Inter-Agency Council on Child Abuse and Neglect) and the Rainbow House Board of Directors recognized the need for a child advocacy center. In August of 1998, the Rainbow House Regional Child Advocacy Center (CAC) began conducting forensic interviews, remaining true to the Rainbow House mission of keeping children safe and supporting families in crisis. The CAC offers a child-friendly environment where abused and neglected children are interviewed. Utilizing a multi-disciplinary team approach, the CAC works with the investigative personnel from law enforcement, children's division, juvenile office and prosecuting attorney's offices to coordinate the best and most effective response to allegations of sexual and severe physical abuse of a child. Every effort is made to interview a child only one time.

Rainbow House has progressively provided services to greater numbers of children over the years. In 2018, more than 546 children received services in the Rainbow House programs.

Rainbow House is staffed by trained, qualified individuals, experienced in working with children in crisis situations. Staff and volunteers undergo background checks and training to provide the highest level of care.

# The Children's Emergency Shelter

Rainbow House Children's Emergency Shelter works to:

- Provide a safe, stable, loving home for children in crisis
- Keep sibling groups together
- Keep children in their home schools
- Work with families to address the crisis situation and strengthen parenting skills
- Provide counseling services to children and families
- Assist with children's clothing and other physical needs

Be a support system and advocate for families and children in crisis.

When children need a safe place to live during a family crisis or after experiencing abuse or neglect in the home, the Children's Emergency Shelter can provide a safe haven for children from birth to 18 years of age.

Children's Division may admit children because they have been removed from their home and will stay at Rainbow House until a foster placement can be found, or they may be admitted through our Crisis Care program. Crisis Care is truly a "prevention" service in that it gives the parent time to establish stability in their lives, possibly preventing abuse or neglect to the child. The Children's Emergency Shelter also offers hourly respite care services to families experiencing overwhelming stress. Much like Crisis Care, this service allows parents to establish stability in their lives, while knowing their children are safe.

It is the goal of the Shelter to reduce the emotional trauma suffered by children who have experienced abuse, neglect, or family crisis, in a safe and loving place. Through home-cooked meals, recreational outings and activities, and loving, nurturing Youth Specialists, we hope to return the feelings of family and stability to each child at the shelter.

## Rainbow House - Regional Child Advocacy Center

The Child Advocacy Center serves children and families in eleven counties in the state of Missouri. Rainbow House's CAC is one of 15 in the state and has been serving children since 1998. The Rainbow House CAC serves children and families in the following counties:

Adair, Audrain, Boone, Callaway, Cole, Cooper, Howard, Macon, Monroe, Randolph, Shelby
The CAC works to make children and families comfortable and safe during their visit to Rainbow House. A child is brought to the CAC when it is believed that abuse has occurred. Rainbow House is a safe, child-focused environment where a child talks with a trained interviewer who knows the right questions to ask during a forensic interview. A Multi-Disciplinary Team that includes law enforcement, Children's Division, medical and mental health professionals, prosecutors and other professionals work together to made decisions about how to help the child. The child and family also work with a specially trained advocate who will link the family to necessary services that begin the healing process when abuse has occurred.

#### **Clinical Programs**

The Clinical Program at Rainbow House encompasses the therapy services and outreach programs that we provide to the families and children we serve.

Children and families can utilize our expertise and dedication to ending child maltreatment and healing its wounds. Use of our family advocacy program and numerous therapeutic services are available to all children and families in crisis, preference given to children and families who are clients of Rainbow House.

### **Therapy Services**

Rainbow House provides therapy to children through the Children's Emergency Shelter and Regional

# Child Advocacy Center.

The Emergency Children's Shelter offers therapy and resource assistance both while the child is in residence and after they leave our doorstep.

The CAC provides therapy services and referrals to children and families post-forensic interview. Outpatient therapy for victims of sexual abuse (who have not had interviews at the CAC) is available on a limited and short-term basis for both individuals and families. Therapy is focused on abuse and trauma and can include court preparation support when needed. Play therapy and other approaches are used to assist a child or family in managing the disruption, and pain associated with sexual abuse. We also assist families in connecting with other qualified therapists for long-term and out-of-county counseling needs. **Rainbow House Support Groups** 

Family Advocate Program serves the child and non-offending caregiver who have been victimized through child abuse and neglect. The Advocate focuses on the needs of the family, offers support to the

family, and assistance in connecting them with appropriate community resources. The Advocate works in concert with other agencies to ensure that the child receives the best services available and that the family is empowered to move forward.
