Damage Security Deposit for Equipment Rental Damages

Renter understands that the Damage Security Deposit (\$1500) is a deposit against all costs of replacement, repairs or cleaning that may be required as a result of physical damage to the equipment during the rental period or against any liability that I may incur to *Island Style Fun LLC* pursuant to this agreement. Further, Renter is responsible for all damages and/or losses to the equipment or any of its contents during that period. The Damage Security Deposit must be paid in full before the equipment is removed from the premises. The Damage Security Deposit will be held until the equipment is returned at the end of the rental period, cleaned, checked mechanically and otherwise processed. All rental expenses will be deducted from the deposit and the balance returned in the same manner in which it was paid. Renter is liable for all loss or damage to the equipment, which can be well in excess of the Damage Security Deposit held, up to and including the replacement cost of the equipment.
