

Terms of Service

Effective Date: November 4, 2025

Welcome to OpenIdeas.group and our community platform at openideas.discourse.group (collectively, the "Service"). These Terms of Service ("Terms") govern your access to and use of our Service.

By accessing or using the Service, you agree to be bound by these Terms. If you do not agree to these Terms, do not use the Service.

1. Acceptance of Terms
