CALL TO ORDER/CERTIFICATION OF QUORUM

Mr. Alfredo C. Ramos, Chairman of the Board, called the meeting to order and presided over the same. Atty. Iris Marie U. Carpio-Duque, Corporate Secretary, recorded the minutes of the proceedings.

The Secretary certified that notices of the Annual Stockholder's Meeting were sent to all the stockholders as of record date in accordance with the Corporation's By-Laws and the Rules of the Securities and Exchange Commission ("SEC") and the Philippine Stock Exchange ("PSE"), and that a quorum existed for the valid transaction of business, there being present or represented at the meeting stockholders holding 223,934,502,045 common shares, which represents 85.6952% of the total outstanding common and preferred shares of the Corporation. The Chairman then proceeded to inform the stockholders that copies of the Annual Report and Audited Financial Statements for 2018 were previously distributed to the stockholders. Mr. Gilbert V. Rabago, Finance and Admin. Manager, briefly presented the financial and operations highlights for year 2018 and explained the salient points thereof.

Thereafter, there being no further questions from the stockholders, on motion duly made and seconded, the Annual Report, together with the Corporation's Audited Financial Statements as of December 31, 2018, was noted and approved.

APPOINTMENT OF AUDITORS


