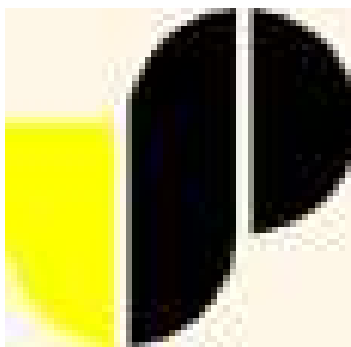

**Dear Mr. G.A. S. Ramos:**

This refers to your Letter dated June 22, 2020, requesting for a one-year extension of the term of Exploration Permit (EP) No. 016-2016-V, in view of the Luzon-wide community quarantine imposed by the Government.

Our evaluation of the said request shows that the abovementioned reason falls within the definition of "*Force Majeure*" as provided under Section 5(al) of the Department of Environment and Natural Resources Administrative Order No. 2010-21, the consolidated implementing rules and regulations of Republic Act No. 7942, the Philippine Mining Act of 1995.

In this regard, the request is hereby approved. However, considering that the said quarantine has started only on March 16, 2020, the period of extension that can be granted is **six months** only. Hence, the period of EP-016-2016-V is extended up to **February 19, 2021**.
