"There are no associated risks in the business operations of United Paragon Mining Corporation (the "Company" or "Corporation") considering that the Company does not have operations at present. The management has issued the following policy providing several preventive measures to combat the COVID-19 disease to be strictly implemented for Longos mine site employees during the quarantine period imposed by the government:

- 1. Any employee suffering from any of the following: fever with temperature of more than 37.8° C, dry cough or cough with phlegm, colds or having shortness of breath/difficulty in breathing, shall not be allowed to report for work. An employee who will report for work despite having any of the stated symptoms shall automatically be sent home, and will report to work only upon submission of a fit-to-work medical certificate from a licensed physician.
- 2. All employees must declare his or her personal travel plans to his/her immediate superior. In case the employee pushed through with the travel, he or she is required to self-quarantine for fourteen (14) days, and will report to work only upon submission of a fit-to-work medical certificate from a licensed physician.
- 3. Any employee who has had any form of direct contact with a confirmed COVID-19 case shall immediately disclose the same to his immediate superior who shall have the responsibility to immediately report the same to management. The employee shall be required to self-quarantine for 14 days counted from contact date. S/he will report to work only upon submission of a fit-to-work medical certificate from a licensed physician. However, management has the discretion to extend the quarantine period as it deems to the best interest of all employees in the workplace.
- 4. Stay-in employees are discouraged from leaving the mine site and shall limit trips to medical reasons and/or to obtain essential supplies.
- 5. Directors, officers and employees will avoid in-person meetings, and may use video or teleconferencing as far as practicable.
- 6. Everyone is encouraged to practice proper personal hygiene such as hand washing, use of alcohol or hand sanitizer that contains at least 70% alcohol, proper cough etiquette, etc.

The guards were instructed to take the temperature of anyone entering the premises and to prohibit entry to any person displaying any symptom.

Furthermore, the annual meeting of stockholders to be held in May as per the by-laws of the Corporation will be postponed until further notice."
