

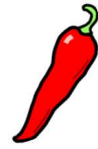

VENDORS BOOTH RULES

➤➤ This is an OUTDOOR EVENT. There will be no refund for inclement weather.

VENDOR SETUP BEGINS AT 9 AM. The event runs until the cook-off winners are announced, at approximately 4:00 pm. NO vehicles are allowed on location during the event except for loading and unloading. **NEW FOR 2026: For setup, enter from 4th Street. See layout. VENDORS WILL BE SET UP IN THE NEW FIRE STATION. TENTS ARE OPTIONAL!!**

COST

➤ \$30.00 per space. Maximum two spaces per vendor. **Spaces are limited! If this is your first year participating in the event, payment must be made at the time of registration. Returning vendors, please pay by Dec. 1st.** Spaces are 10'x12'. All spaces must be paid in advance. You must complete the registration form in advance (either in hard copy or electronically) and check in at the new fire station, where you will be directed to your designated space. **THERE WILL BE NO REGISTRATION ON EVENT DAY.**

BOOTHS

➤ Exhibitors must provide their display tables/materials and are responsible for keeping the area clean. No security will be provided. Booths, canopies, display cases, tie-down stakes, and all materials must fit within the space provided. Electricity will not be provided. Water will be available at the fire station. **NEW: For air quality/safety reasons, generators are not permitted inside the fire station.**

PARKING

➤ All vehicles must be moved to a designated parking area after unloading and setting up. Handicapped parking will be available with advanced notice. Parking along streets is permitted, but DO NOT BLOCK driveways.

TRASH

➤ Trash cans and a trash trailer will be available.

CANCELLATIONS

➤ If the event is canceled due to any County, State, or Federal Government proclamation or other order legally prohibiting this gathering, the registration entry fee will be refunded. There will be no other refunds.

OTHER:

➤ For the general public's safety, please do not bring pets. Service animals are allowed

➤ **No Prohibited Activities:** No part of the activities of the Corporation shall be to influence or attempt to influence legislation. The Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. The Corporation shall not participate in any other activities that are not permitted by a tax-exempt Corporation under section 501(c)(3) of the Internal Revenue Code, or by a Corporation whose contributions are deductible under section 170(c)(2) of the Internal Revenue Code.
