### LIBRARY/RECREATION:

#### **PUBLIC SAFETY:**

Mary reported borough had received notice from Butler County Emergency Management Services that we need a new EMA coordinator as Eric Hilliard is not qualified since he has not taken any of the classes required for this position. The borough will receive no funding from FEMA should an emergency situation arise. Asked Attorney Menchyk to direct us as how to proceed on this issue. Eric stated he had not received the information about this situation. He will check into it and report back.

Discussed Country Lane Subdivision and KLH Engineers review letter. Sam Gibson, KLH Eng. stated that some reports were incomplete and need done so the borough can approve. Andy stated that Connoquenessing Twp. Had approved their portion of lots contingent upon Prospect approval.

#### STORMWATER MANAGEMENT AND STREETS:

**Old Business:** Harmon Lane (Rt 528 culverts need replaced with 12" pipe, 12" deep.) The state at some point will be ditching the edge of the road. It is still unclear how many entrances in Harmon Lane we will be doing the culverts on. To be completed in suitable weather.

Nick reported a pothole on Wilson Road in front of Wiltrout property. He also reported the entrance to the George Wagner property where buses are parked creates an issue and should be looked at and have a proper entry apron put in place.

**New Business:** Gus reported the Corp pf Army Engineers grant project that Nick wanted approved last month was not applicable to Prospect Borough. Issue disregarded.
