The listed nominees have been duly nominated for the offices of Council for the ᐃakisqnuq First Nation in accordance with the *ᐃakisqnuq First Nation Custom Election Regulations (2026)*.

TO BECOME A CANDIDATE – Nominees were asked at the time of nomination to verbally accept or decline their nomination. Nominees who accepted the nomination must complete the following documents within 72 hours of accepting the nomination (**no later than 7 p.m. on April 10, 2026**):

- (i) Acceptance of Nomination;
- (ii) criminal records check (including a vulnerable sector check)/proof of application;
- (iii) Declaration confirming their eligibility as a candidate.

The final document deadline for a Candidate to provide the Electoral Officer with their Criminal Record Check and five (5) year Driver's Abstract is **4:00 p.m. on May 3, 2026**.

Anyone nominated who does not comply with the requirements as set out in the *ᐃakisqnuq First Nation Custom Election Regulations* shall be disqualified from being a candidate.

ALL-CANDIDATES FORUM - All persons who have accepted nomination and are deemed eligible for Council must participate in an All-Candidates Forum, at a time and place to be determined by the Electoral Officer. Candidates may elect to participate virtually.

BALLOT NAME – If you are a nominee and would like your name to appear differently than the way it is written on this preliminary list, please email OneFeather Support listed below by **April 12, 2026**, and indicate how you would like your name to appear on the ballot. After that date, no further changes will be possible.
