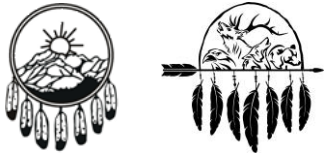

To date, we have focused on three areas as the cornerstones of our operations:

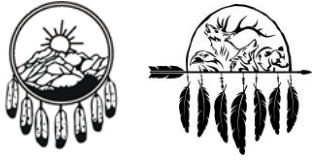
- 1) Tourism and Wellness

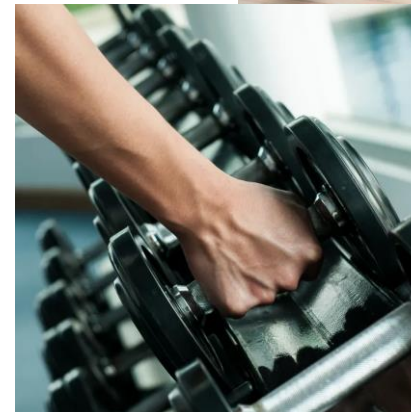
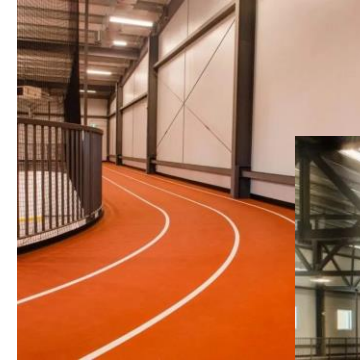

Tourism and Wellness

Columbia Lake Recreation Centre

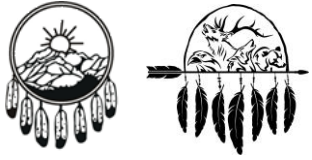
- Developed New Operations Manual (2025)
- Purchased new weight room equipment and gym equipment
- Successfully marketed to a number of organizations leading to regularly scheduled bookings
- Installed acoustics treatment in June 2024 that will allow for even more booking opportunities
- With the improvements we are seeing increased customer volumes leading to increased revenues for AFN Enterprises

Lakeshore Resort and Campground

- Opened May long weekend
- New website at www.lakeshorecampground.ca
- New reservation system through **Campspot**
- We set a goal of booking 500 nights this year. As of July 6th we had 747 nights booked
- Purchased kayaks to rent out to campers
- Beginning a program of replacing campground tables

Property Development

Purchase of 625 4th Street, Invermere

- We have extended the lease with Mountain Creek Properties to May 31, 2027
- We have concluded lease negotiations with Government of BC, with rent increasing approximately 18% in new lease
- Working with District of Invermere on a grant application to enhance the sewer infrastructure adjacent to our property.
- This will provide us with more options to develop the property, which will also increase property value
- Using this opportunity to provide knowledge to Council and staff of District of Invermere that they are on Ktunaxa Traditional Territories

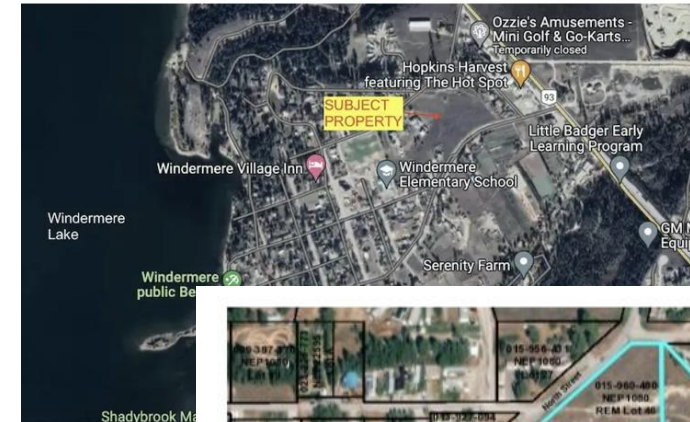

Windermere Property Development

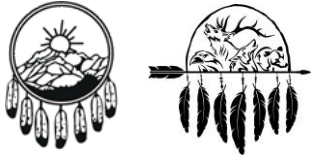
- Purchased May 2024
- 11.6 acres that can eventually support up to 131 homes
- Will include properties for rent and for sale
- The rentals will support ʔakisq̓nuk community and staffing needs
- Help to enhance the services the Nation can provide to the community
- Provide employment opportunities through construction, strata and property management

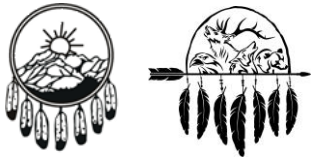

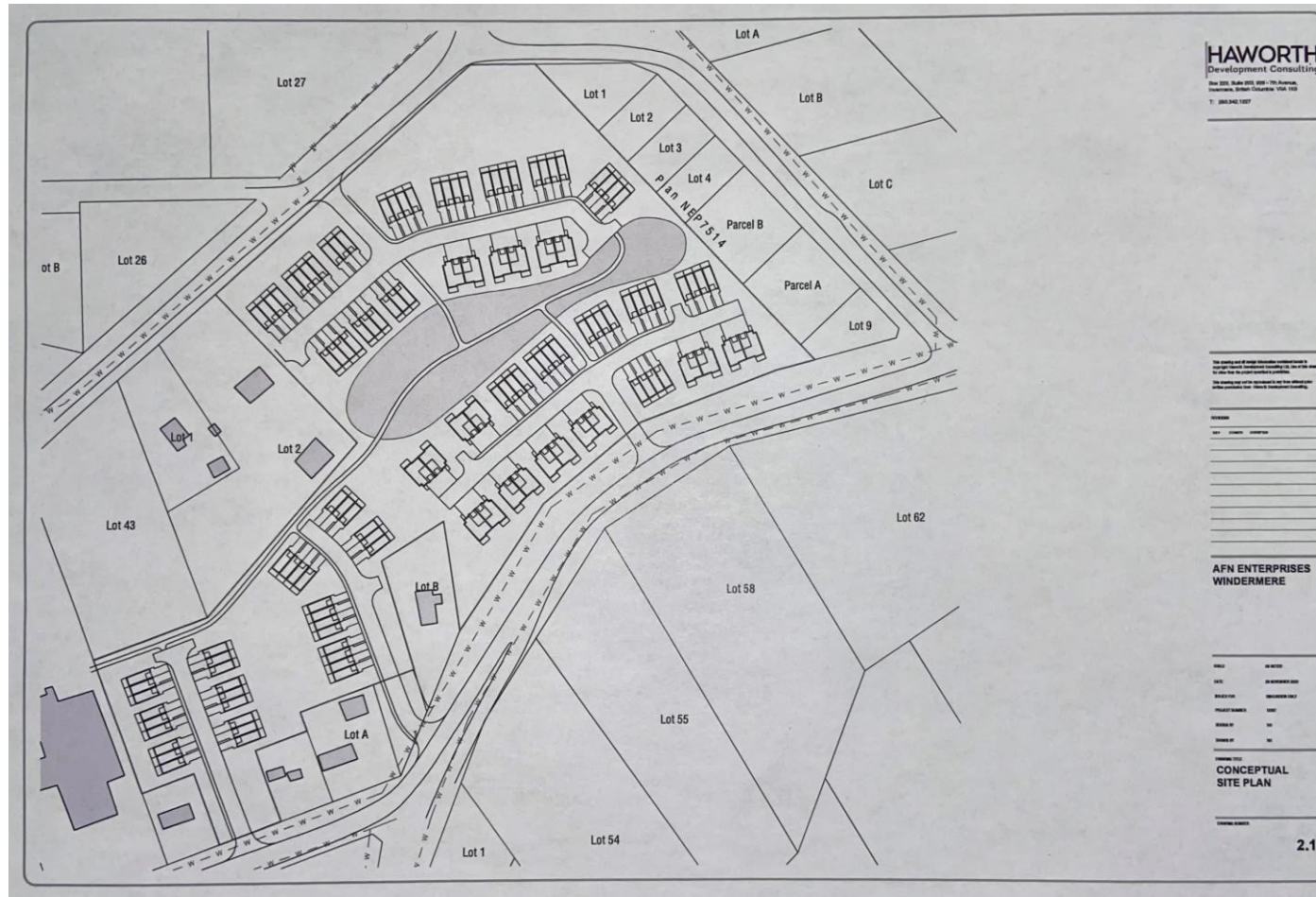
Windermere Property Development (continued)

- This land is very close to Hopkins Harvest, the Fire Department, the elementary school and is very walkable
- ʔakisq̓nuk First Nation is approximately 1 km away from the property, making it attractive to our staff and Community Members
- Development of residential properties would increase the market for the proposed commercial lot at ʔakisq̓nuk First Nation
- Close to Beach and Lake access and many outdoor amenities making it an ideal community to live in
- Little Badgers Daycare 1 km away at ʔakisq̓nuk First Nation.
- There is potential to develop a “market square” within the development to promote community and increase employment opportunities



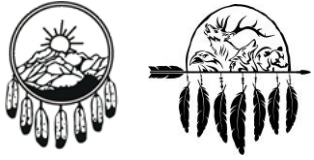

Property Development

- We have had the property re-zoned for the development we plan
- We have had geotechnical work completed
- We are presently doing the traffic surveys
- We are in discussions with some home-builders to begin pricing out the costs of building
- Received a grant for the “pre-development” work and will be applying for grants to lower the costs of development and enhance the economics of the project. (approximately \$95,000)

New Opportunities

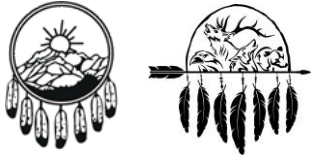
- We continue to explore many new opportunities that come to us on a regular basis
- In discussions about an equity opportunity in a **mass-timber production facility**
- The new Trump tariffs have caused some uncertainty
- We are also in preliminary discussions about an equity opportunity in a **trucking and hauling company**
- We are exploring an investment in **data centres** across Canada.
- There are other **property development opportunities** within Ktunaxa Traditional Territories – particularly in district of Invermere
