EVERY VOTE COUNTS



Mid-term elections in November 2018 are turning out to be very important to the health of our democracy. Speigal Online reports: “democracy faced its most serious crisis in decades.” It went on to note that, “the right to choose leaders in free and fair elections, freedom of the press and the rule of law are under assault and in retreat globally.”

The people (1 in 6 voters has a disability) have the power through advocacy and through voting to choose candidates, who respect the rule of law, respect the constitution, and who aren't bought by political action committees (PAC's). Are you registered? How do you get registered?

To register to vote, you must be all of the following and apply at least 30 days before an election:

- A U.S. citizen
- At least 18 years old by Election Day
- A resident of Michigan
- A resident of the city or township where you are applying to register to vote.

You can begin the process here online at www.Michigan.gov/sos, at the local Secretary of State office or attend a voter registration drive. The next drive in Kalamazoo County is on August 4th at LaCrone Park. Keep an eye on our website (www.communityadvocates.org,) or our facebook page for more upcoming registration events.

We Need Your Voice! Entitlements (Medicaid, Medicare, Social Security) and the ACA are under attack! The current Congress is moving behind

closed doors and in a partisan fashion to make cuts to the very benefits that provide vital supports and services to individuals with disabilities. They are moving to do so before mid-terms in November. Call or write your elected officials and let them know how cuts will affect you!

Each state elects two senators to the United States Senate for staggered 6-year terms. Senators represent the entire state. Michigan's senators are:

In 1987, one man's dream of riding his bike across the country came true. What he did not know was the inspiration and motivation his trek across America would give to The Ability Experience. The very next year his ride inspired The Ability Experience to create the largest fraternal fundraising and awareness event of its kind, the Journey of Hope. Today the Journey of Hope covers 32 different states, cycling over 12,000 miles combined, it is solely comprised of members of Pi Kappa Phi and continues to spread a message of acceptance and understanding for people with disabilities.
