In this day and age of social change and as good stewards of grant and donor dollars, one may wonder how we know we are making a difference? For 66 years, The Arc Community Advocates has been the leading Advocate for individuals with a wide range of diagnosis across the spectrum of intellectual and developmental disabilities in Kalamazoo County.

As a society, we have gone from thinking that individuals with disabilities needed to be institutionalized and contribute little to society to recognizing that individuals with disabilities make huge contributions, belong and can thrive in every community. Most individuals with intellectual and developmental disabilities just need additional supports to reach their goals and there is no one size fits all.

Our supports and services can be as simple as an information and referral service, helping individuals and families become empowered and their own self-advocates, to complex assessment of cases in education that require not only

a clinical understanding of the dynamics, but also knowing the law and statues that the education system is required to follow. In addition, we can help you plan the long-term future for your child or adult with a disability. We also advocate for the rights of individuals through the local, state, and federal levels of policy.



Our services are personalized to meet the needs of the individuals at whatever stage of life they are in or approaching. We record hundreds of client contact hours each year and attend various types of meetings. We know the relief parents feel when we walk alongside them to help advocate for their child. The Arc Community Advocates remain committed to speaking up and speaking out to ensure equity and access to the community for all individuals!

For the past several years, The Ability Experience and Pi Kappa Phi members have come together with The Arc Community Advocates for an afternoon of creating awareness for people with disabilities.

We spend the afternoon getting to know each other, playing yard games, grilling out and promoting that disability doesn't mean "inability".

The Ability Experience is the philanthropic initiative of the Pi Kappa Phi fraternity that remains, to this day, an unparalleled success in the Greek world. Founded in 1977, they strive to instill a passion for lifelong service in their fraternity members while helping to empower people living with disabilities.





The Ability Experience creates experiences that promote the abilities of all people and works to eliminate the labels that unfairly define us, especially for those living with disabilities.

In 1987, one man's dream of riding his bike across the country came true. What he did not know was the inspiration and motivation his trek across America would give to The Ability Experience. The very next year his ride inspired The Ability Experience to create the largest fraternal fundraising and awareness event of its kind, the Journey of Hope. Today the Journey of Hope covers 32 different states, cycling over 12,000 miles combined, it is solely comprised of members of Pi Kappa Phi and continues to spread a message of acceptance and understanding for people with disabilities.
