Ahh yes, school is just around the corner, for some it means excitement, for others, especially individuals and families affected by intellectual and or developmental disability, it may mean anxiety, frustration and uncertainty for the future of their child.

For The Arc Community Advocates, it is a chance to educate and empower parents and students to be self-advocates and to help with a solutions-based approach to help bridge any gaps between the school and the families.

Sixty-eight present of our free services is in Special Education Advocacy and it is not uncommon for us to be carrying over

100 open cases during any one school year that range from early on education to transition to adulthood. Our partnership with the Michigan Alliance for Families (MAF) and other like serving agencies like ASK Family Services helps to build a navigational foundation for families through collaborative training and parent mentoring.

Finally, our Systems Advocacy is how we hold governmental and educational entities accountable in the implementation of law, policy, procedures and an equitable education for those we serve. We share that information with you because together, our voices impact social change and the rights of all students to access the best education possible and entitled by law. From the first bell in September throughout the year, we are here for you!

PARENT CHECKLIST FOR BACK TO SCHOOL

SCHEDULE

- ☐ Any medical/dental or other checkups needed before school starts
- ☐ Start moving toward bedtime routines
- ☐ Talk to your child about starting school and help him/her work through any back to school jitters

PREPARE

- ☐ Re-read IEP to be sure you understand it and that it meets your child's needs.
- ☐ IEP Binder with all special ed paperwork
- ☐ A school year calendar to keep track of absences, important conversations with staff, suspensions or specific events you want to remember.
- ☐ Medical records for any medical special needs.



TO DO

- ☐ Visit school with child before school starts, check out the playground or library if available.
- ☐ Attend Back to School night, let teacher know if your child has an IEP or 504 plan.
- ☐ Send a note to teacher requesting a quick meeting around 3-4 weeks into school to personally provide copy of IEP or 504 plan.
- ☐ Make copies of all school communications and insert into your IEP binder
- ☐ Remember, if it's not in writing, it didn't happen!
