It has been a year marked by both challenges and triumphs, and as the agency's first African American Executive Director in our 71 year history, I am profoundly grateful for the unwavering dedication and support of our entire community.

This year, we faced obstacles that tested our resilience and adaptability. From navigating unexpected shifts in our sector to responding to the evolving needs of those we serve, each challenge was met with a spirit of collaboration and innovation. It is through these experiences that we have grown stronger and more united.

1. We strengthened our connections with the community through increased community partnership with agencies like the Maple Hill Auto Group, The Great Lakes Center for Autism Treatment and Research, the Pokagon Band of Potawatomi Indians, Challenger Jamboree, and the Douglass Community Center. These interactions have deepened our understanding and expanded our ability to address the intersectional needs of those we serve.
2. Internally, we have seen significant growth in accessing and leveraging national and statewide collaborations. Partnerships with The Arc United States, Amazon, and the Michigan Assistive Technology Program through the Michigan Disability Rights Coalition has enhanced our capacity to deliver on our mission beyond our service areas and prepared us for future opportunities.

None of these achievements would have been possible without the commitment and hard work of our staff, board of directors, volunteers, donors, and partners. Your belief in our vision and your generous support have been the driving force behind our success.

Jacob Soule

I am Jacob's mom, Katie Soule and I would love to provide an update because I feel like Jacob is such a success story within the (autism) community! He is now 22 years old and has moved into his first apartment to start his junior year at Western Michigan University. He is an Environmental Geography major and works closely with WMU's Autism Services Center to stay organized and communicative with professors and other staff. In addition to being a full time college student, he is employed at the Children's Nature Playscape downtown near Bronson Park where he works with children as an outdoor educator. He still isn't driving and I don't know if he ever will, but he has learned how to navigate the Metro bus system like a champ and really gets around.

He was also recently contacted by an investor who would like to partner with him to start an online greenhouse business using his international social media connections, which continue to grow. This opportunity is very exciting to Jacob and our whole family!

As I brag about all of this, I just have to say that without Annie and the Arc Community Advocates, I don't know how much of it would've happened. As a high school counselor with a master's degree in counselor education I STILL struggled advocating for my own son in school and community settings. Even though I had participated in countless IEPs for my students, it was extremely different to be sitting on the other side of the table as a parent. The emotional element clouded my judgment and made me less effective.

In addition to the expertise the Arc brought to the table, Annie also provided a level of calm. Inside of this calm is where solid and logical work got done. I have worked with the Arc both personally as Jacob's mom and professionally as a school counselor. I can say that in both situations when emotions run high, all parties can lose sight of the ultimate goal we all work towards: Helping ALL children succeed by reaching their full potential.



I am so thankful for the Arc Community Advocates in their tireless quest to help children, parents, educators, and various agency personnel strive to be the best we all can be as we navigate life with our most vulnerable populations. I know that Jacob has had a better life because of them and I am positive there are many stories like his out there!

The Arc Partners with Amazon

Technology is deeply embedded in our lives, but for people with intellectual and developmental disabilities (IDD), the barrier to accessing technology can be disproportionately high, even as a community that could greatly benefit from its impact.
