Tribunal Services

Appeals can vary greatly in the number of hours required to complete and there is no shortcut or way to speed up the process. As a company we aim to get cases settled without the need for a hearing, thus reducing the time it takes to reach a settlement. However, nothing in the SEND world moves quickly and a lot of hours are spent in reading and reviewing documents and discussing with colleagues the best way to move forward in each individual case. In our experience Tribunal cases can take as little as 15 hours or they can take over 100 hours.

We are mindful of the increasing costs when appealing to the SEND Tribunal so to make it easier for our clients to budget, we are introducing a cap on the costs of Tribunal support. This means that you will be billed monthly for our services until you reach the cap of £7500. All following work will be done Pro Bono except for Representation at court. As a company we aim to empower parents to manage their hearing however, we can provide representation at the hearing if required. Representation at court is billed separately at a fixed price and is not included in the capped price.
