He registered his own company, Wolds Environmental Consulting Ltd, in September 2019 with a focus on the continued delivery of high quality applied environmental research and management support across coastal and marine waters.
- Wolds Environmental Consulting Ltd is a Micro-Business (an SME with less than ten employees) operating from a domestic UK setting in East Yorkshire.
