FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR CAROLINA LANDING SUBDIVISION

THIS AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR CAROLINA LANDING SUBDIVISION (the "Amendment") is made and entered into effective as of August 11, 2022 by LAST INVESTMENTS, LLC, a North Carolina limited liability company ("Declarant) and SCOTT LEE HOMES, INC., a North Carolina corporation limited ("Owner").

# **RECITALS:**

WHEREAS, Declarant recorded the Declaration of Covenants, Conditions and Restrictions for Carolina Landing Subdivision was is recorded in Deed Book 5788, Page 387, Johnston County Registry (the "Declaration"); and

WHEREAS. Declarant now desire to amend the Declaration as set forth herein; and

WHEREAS, Owner owns several lots in Carolina Landing Subdivision and joins in the execution of this Amendment to acknowledge the amendment to the Declaration as contained herein.

NOW, THEREFORE, the Declaration is hereby amended as follows:

1. Section 2 of the Initial Use Restrictions and Rules, set forth in Exhibit "C" to the Declaration, shall be amended by adding the following revisions to said Section 2:

Subparagraph (c) shall be replaced with the following paragraph:

(c) No animals, livestock, or poultry of any kind shall be raised, bred, or kept on any portion of the Properties, except a maximum of three (3) dogs, cats, or other usual and

common household pets may be permitted in a Unit. Owners shall leash their pets when outside of the dwelling. No pets shall be kept, bred, or maintained for any commercial purpose. Further, there shall be no vicious dog breeds kept in, on or about any any Unit, including, but not limited to, pit bulls and rottweilers,

Subparagraph (w) shall be added to the end of Section 2:

- (w) Prior to any Unit Owner installing solar panels, photoelectric cell panels or similar type of solar energy collectors on any home in Carolina Landing, the Declarant and Association must approve in writing the installation and location of such solar panels, photoelectric cell panels or similar type of solar energy collectors. Further, all solar panels, photoelectric cell panels or similar type of solar energy collectors must be installed on the rear roof area of any home and may not be located in any yard on any Unit.
- 2. Except as amended herein, all remaining provisions of the Declaration shall remain in full force and effect.
