**SUPPLEMENTARY PROTECTIVE COVENANTS  
FOR BENNINGTON PLACE SUBDIVISION  
PHASE VI**

THIS SUPPLEMENTARY DECLARATION, made this 13<sup>th</sup> day of September, 1999, by FOUR OAKS BANK & TRUST COMPANY, a North Carolina Corporation, hereinafter referred to as Declarant.

**WITNESSETH:**

WHEREAS, Declarant is the owner of certain real property located in the Town of Clayton, Clayton Township, Johnston County, North Carolina, which is more particularly described as Bennington Place Subdivision, Phase VI, recorded in Plat Book 55, Page 21, Johnston County Registry, reference to which is hereby made; and,

WHEREAS, Declarant will convey said real property subject to the covenants, conditions, restrictions, reservations and charges as set forth in that certain Protective Covenants recorded in Deed Book 1775, Page 749, Johnston County Registry, and which shall run with the lots and be binding on all parties having any right, title or interest therein and their heirs, successors and assigns, and which shall inure to the benefit of each owner thereof; and,

WHEREAS, Declarant desires to insure the most appropriate development and improvement of each lot, to protect the lot owners against such improper use as would depreciate the value of the property to each, to preserve insofar as practicable the natural beauty of each lot, to guard against the erection thereon of poorly designed or proportioned structures and structures built of substandard or unsuitable materials, to secure and maintain proper setbacks with adequate free space between structures, and in general to provide for a high quality of improvements.

NOW, THEREFORE, Declarant hereby declares that all of the real property as described hereinabove shall be held, sold and conveyed subject to that certain Protective Covenants recorded in Deed Book 1775, Page 749, Johnston County Registry.

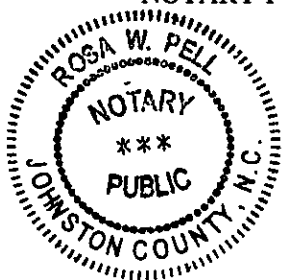
