WHEREAS, Declarant will convey said real property subject to the covenants, conditions, restrictions, reservations and charges as set forth in that certain Protective Covenants recorded in Deed Book 1775, Page 749, Johnston County Registry, except as amended hereinbelow, and which shall run with the lots and be binding on all parties having any right, title or interest therein and their heirs, successors and assigns, and which shall inure to the benefit of each owner thereof; and,

WHEREAS, Declarant desires to insure the most appropriate development and improvement of each lot, to protect the lot owners against such improper use as would depreciate the value of the property to each, to preserve insofar as practicable the natural beauty of each lot, to guard against the erection thereon of poorly designed or proportioned structures and structures built of substandard or unsuitable materials, to secure and maintain proper setbacks with adequate free space between structures, and in general to provide for a high quality of improvements.

NOW, THEREFORE, Declarant hereby declares that all of the real property as described hereinabove shall be held, sold and conveyed subject to that certain Protective Covenants recorded in Deed Book 1775, Page 749, Johnston County Registry, except as amended hereinbelow.

Declarant hereby amends Article X, Section 5 of said Restrictive Covenants to read as follows:

Article X, Section 5. <u>Dwelling Size</u>. No residential structure which has an area less than one thousand (1,000) finished, heated square feet, exclusive of porches, breezeways, steps and

garages, shall be erected, placed or permitted to remain on any lot. Any multi-story house shall have at least 600 square feet of heated area on the first floor, with a total of at least 1,000 square feet of heated living area overall. The Architectural Review Board shall have the right to allow a 10% deviation from this requirement.
