In return for today's participation and use of facilities at the OCHC sponsored event and on all future dates, with regards to the use of property, facilities and services of the OCHC, and the participating landowners (County of Orange, 211 Rt. 416, Montgomery NY 12549), Participant his/her heirs, assigns and legal representatives, hereby expressly agree to the following: I understand that the sport of horseback riding and driving is inherently dangerous and that serious injury and death can occur. I understand that participation in equine activities involves necessary risks. I agree that if any injury occurs to my horse or myself or to any equipment that I may use or send to use, I will make no claim against the OCHC, and/or any of the officers, directors, trustees, employees and volunteers, or against County of Orange. I further agree to hold the aforementioned free and harmless from any liability, claims, suits, or damages of whatsoever kind or nature that may be occasioned by the horses used by me or the negligence of the persons in charge of such horses and I agree to indemnify and hold harmless these organizations and individuals against all liability claims, suits and expenses, including attorney fees incurred arising out of any injury to any person or damage to any property caused by me, my horses or attendants. I fully understand the above and agree to abide by all OCHC and New York State Horse Council rules, policies and specifications for this type of event. This contract is non-assignable and non-transferable and is made and entered into in the State of New York, and shall be enforced and interpreted under the laws of this state.
