I further agree to hold the aforementioned free and harmless from any liability, claims, suits, or damages of whatsoever kind or nature that may be occasioned by the horses used by me or the negligence of the persons in charge of such horses and I agree to indemnify and hold harmless these organizations and individuals against all liability claims, suits and expenses, including attorney fees incurred arising out of any injury to any person or damage to any property caused by me, my horses or attendants. I fully understand the above and agree to abide by all OCHC and New York State Horse Council rules, policies and specifications for this type of event. This contract is non-assignable and non-transferable and is made and entered into in the State of New York, and shall be enforced and interpreted under the laws of this state.
